Admission to Class XI – 2026-2027

As discussed during the meeting held with the students and the parents of Grade X, the subject streams that are offered and the eligibility criteria for admission of Grade XI is given below.

Eligibility criteria for Admission to Class XI -2026-27

*Admission to Class XI will be on the basis of the performance in Class X- First term (40%), Best of the Pre-Board Examination (60%) marks and the weightage of the score in Mathematics.

*The weightage of the score in Science and Mathematics will be considered for admission to the Science stream.

The weightage of the score in Mathematics will be considered for admission to the Commerce stream.

*A rank list will be prepared based on the above-mentioned criteria.

*Groups will be allotted to the students according to their rank and the maximum number of seats available in each group as given above. A student can move down in the order of groups according to her/his interest if seats are available.

*A student can move to the immediate next higher group, if seats are vacant in that group for which the aptitude and the performance will be considered.

* Students are restricted to only one chance to change their group.

*The parents must clear the outstanding fee of class X (Academic year 2025 – 26), if any, payment of the first quarter fee of class XI within the admission period and reporting to the class teacher are mandatory for a student getting admitted in a group; otherwise, the seat is considered as vacant.

* In the absence of a minimum of 20 applicants for any subject, that subject will not be allotted and the students who applied for the subject, should have to change to the other subject options based on their score.

*Kindly note that admission to Class XI is final.

*The decision of the admission committee will be final and any further request will not be entertained.

*The subject registered for Class XI will remain the same in Class XII. Changes are not permissible.

NB-The students shall be intimated (through mail) regarding the group/ stream that they have been allotted.
